Page 1, Line 10: \$16,104 represents the balance paid for the purchase of our 5th Track-Chair \$7,554, six new batteries for the Track-Chairs \$1,462, and misc. associated maintenance and fitting out of the Track-Chairs \$258, and end of year Volunteer Appreciation cards \$650.

This amount also includes taxidermy for a Horned Owl mount for the Visitors Center \$550, and landscaping around the Visitors Center \$1,000, Industrial grade tarps to cover the roof of the Staunton Historic Cabin \$4180, and building materials to construct a Bocce Ball court \$450.

Page 1, Line 16: \$2,463 was not an expense, but transfers from two restricted accounts, and one temporarily restricted account, into other funds as the donors requested.

-- [Redacted] donated \$588 from a cycling event they held to help maintain trails. Upon discussion, they released those funds from a Trail Maintenance restricted fund into general funds.

--The [Redacted] fund was a temporarily restricted fund that covered a variety of projects that he had a specific interest in. In March 2020, [Redacted] asked us to move the balance of that temporarily restricted fund of \$1,785 into the restricted Staunton Cabin Restoration Fund.

--The Colorado Parks FD-Trash Can Restricted Fund had a balance from 2017 of \$90 that remained after the purchase of the trash cans, and gave permission to release those restricted funds to be used for other general purchases.

We received written permission to release all three of these restricted balances, copies of which are included in our records.
